#### Guide to the Sustainable Development Goals (SDGs)

Innovation project for the Industrial Sector

#### Introduction

The UN Sustainable Development Goals (SDGs) constitute the world action plan for sustainable development, specified through 17 goals and 169 targets which aim to achieve sustainable development along three dimensions: economic, societal and environmental. The goals are ambitious and address global challenges, but are based on local adaptation and action. They are relevant for all industries and sectors.

More and more companies are using the SDGs as the basis for their work and see the potential of thinking sustainably. With the help of capital, innovation capacity and expertise in the private sector, new sustainable solutions are constantly being developed for the future. The Research Council wants to help Norwegian companies take their share of the market that the SDGs trigger, with innovations that meet global and/or national challenges. We expect companies to have sustainability as a key element in their projects when we fund them, because sustainability strengthens long-term competitiveness and value creation.

We will therefore emphasize sustainability when we assess proposals by highlighting this in the assessment criterion called Impact. From 2022 contributions to the SDGs are one of four key factors in the criterion. In addition, there is now designated space in the Project Description template for elaborating on the project's contribution to sustainability.

To make it easier to find your way around the SDGs, we have created a guide with all the main goals and targets relevant to projects applying for funding from the Research Council. Furthermore, some examples of relevant innovations and projects are given in the right-hand column. The examples are not exhaustive but give an indication of the type of innovation projects that may be relevant to the individual targets. You can find more information about each target in <u>Norway's action plan for achieving the SDGs by 2030 (St. meld. 40 (2020-2021)</u> where each target is described and set in a Norwegian context (Norwegian only).

Under section 2.1 in the Project Description, you add your description of how your project contributes to achieving the goal (or goals), without having a negative effect on the other goals. There may be several SDGs that is relevant to a project, however, the proposal will not be assessed on the number of targets that the project contributes to achieving. Thus, a list of SDGs without an account of how the project actually contributes to achieving the goals, is considered a deficiency in the application. Thus, the important thing is how well you describe and substantiate that the project will contribute, even if it is on one target only. Furthermore, there should be a good correlation between the work packages planned in the project and the contribution to the SDGs, as well as a description of whether the project's innovations could potentially have negative side effects on some of the other SDGs.

#### Goal 1: End poverty in all its forms everywhere

Targets	Examples of contributions to achieving the target

The target group for the project ought to be defined as socioeconomically vulnerable persons.
Target 1.5: By 2030, build the resilience of the poor and those in vulnerable situations and reduce their exposure and vulnerability to climate-related extreme events and other economic, social and environmental shocks and disasters.	The goal is to increase resilience to crises and disasters of people who are at risk of being affected by them, that is, to reduce people's vulnerability. The target group for the project does not have to be socioeconomically vulnerable people, but any person who, due to crises and disasters, can fall into poverty. May include innovations that contribute to an increased share of local authorities adopting and implementing local disaster preparedness strategies in line with similar national strategies, and/or contributing to an increased share of municipalities with implemented or planned climate protection systems.
